Presenting ECA Activity Plan 2022

Empowered by the vision to act as an internationally acknowledged driver of innovation in accreditation and quality assurance in higher education, ECA will put a special focus on joint programmes and European approach in 2022. The Association will strive to keep the essence of tradition with a modern touch in close cooperation with a strong alliance of 16 members and 3 observers.

The following activities will take place in 2022:

GENERAL MEETINGS AND SEMINARS

Annual General Meeting will take place in June 2022 and will be combined with a seminar, followed by a December 2022 Winter Seminar.

WORKING GROUPS

Joint programmes, recognition and innovation As of December 2021, WG 1 and WG 2 are joint into a new WG on Joint programmes, recognition, and innovation, chaired by Eva Fernandez de Labastida from UNIBASQ. This WG will be mainly focusing on joint programmes and European approach and as a response to a rising demand in this area. The European Universities initiative and their innovative approaches in terms of programmes, including the perspective of a European degree is increasing the interest on the quality assurance of ioint programmes following the European Approach and the need of recognition of these new degrees. In addition, any topic of interest of the members will be discussed in this forum.

Members of WG will meet at least three times in 2022, namely in **April 2022, June 2022, and December 2022.**

Certification Group

The Certification group, chaired by Ronny Heintze from AQAS, continues unchanged and will meet three times in 2022, namely in March 2022, June 2022, and December 2022.

TRAININGS

Considering the growing demand for European Approach, also a result of expandible growth of European Universities in the future, **two trainings** will be organised in 2022, namely:

- 29-30 June 2022

The registration process, as well as programme and location details will follow soon.

WEBINARS

In addition to seminars, **two webinars** will take place in 2022, covering topics of strategic interest for members and observers.

STRATEGIC PROJECTS

In March 2022, ECA will re-open a call for strategic projects proposals in line with the ECA strategy. With this call ECA continues to support the development of projects by its members with the aim of contributing to the strategy of the association and to promote the goals related to higher education quality assurance. The Board agreed on increasing funds for strategic projects to foster mutual collaboration among ECA members.

EU PROJECTS


ECA Winter Seminar and Joint Working Groups Meeting

ECA winter seminar took place online on **13th of December 2021.**

In addition to joint WG meeting, where ECA Activity Plan for 2022 was discussed, the seminar put focus on the **European Framework for Quality Assurance** of **European Universities**, in particular, the applicability of the framework in practice, the results of the <u>EUniQ project</u> and the experience of <u>European universities Alliance</u>. The following speakers participated at the event:

CALOHEE Extension Project

ECA is part of the **Advisory Board** of the **CALOHEE Extension project** which builds on the experience and outcomes of the TUNING – CALOHEE (Measuring and Comparing Achievements of Learning Outcomes in Higher Education in Europe) Project.

The project outcomes intend to strengthen the position of the European and national higher education sector and the degree programmes offered, by evidencing what is actually learned. This involves the development of Subject Area based Qualifications Reference Frameworks (Bachelor and Master) for the wider public and all stakeholders and more detailed Assessment Reference Frameworks for specialists in the field. Both frameworks contribute to the enhancement and fairness of external and internal quality assurance mechanisms.

The project CALOHEE Extension focusses on **5** main subject areas:

- Business Administration
- Information Engineering/ICT
- International Relations
- Medicine and
- Performing and Fine Arts.

For each subject area, a working group is created, made up of fourteen senior staff/ academics and one student.



Updates in the Qual-Al-ty Engagement project

Fostering Student Engagement through Qualitative Quality Assurance Practices (Qual-AItv Engagement) is an Erasmus+ Strategic Partnerships project lead by Riga Technical <u>University</u> and co-lead by <u>ACEEU</u>. Other partners include the University of Twente, the Malta College of Arts, Science and Technology and the European Consortium for Accreditation in higher education.

As a part of the initial phase, the project has already identified <u>good practices applied in Europe</u> <u>regarding the student</u> (and other stakeholders) engagement.

Currently, an important stage of the project is being developed: <u>The Qual-AI-ty Bootcamp.</u> The development of the Bootcamp should allow quality assurance staff from different countries to exchange knowledge and share experience.

Systemic university change towards internationalisation for academia (SUCTIA) project

ECA is a partner of the SUCTIA project aiming to raise awareness and shift the internal culture of HEIs towards internationalisation, creating а systemic change in HEIs and in the European Higher Education Area. SUCTI Academia is built on SUCTI project (2016-2019) which already shown that systemic through trainings for change administrative staff is a key to success. Shifting a culture is only possible through internationalising all groups of higher education institutions. The European report on systemic university changes towards internationalisation for academic staff in European Higher Education Institutions and the <u>SUCTIA Manual</u> are available on the project website.

This will be the basis for promoting student engagement with society proactively and contribute to the convergence of policy and practice in quality assurance in the EU. Additionally, the Bootcamp will allow to envision effective instruments for assessing student engagement with society and a comprehensive Qual-AI-ty Assessment Model to drive the student engagement.

Taking advantage of the digital opportunities, the Bootcamp is going to be organised in an online format, divided in two different sessions:


- 8 February 202:. Focused activity for the quality assurance staff from the consortium.
- 8 March 2022: A second one opened to diverse stakeholders.

This will allow the project to develop the tools and further validate them with a more diverse community of stakeholders.

For this New Year, let me wish you all the best for you and your loved ones. May 2022 reinforce our links and cooperation! The Latvian Quality Agency for Higher Education (AIKA) presents analysis on organisation of the site visits in online mode

In December 2021 AIKA published **analysis on the site visits organised from March 2020 until December 2021**. Majority of these site visits took place in a semi-online format with some experts participating on-site and some experts online.

The analysis was based on the feedback received from the higher education institutions reviewed and the review experts. The analysis covers 79 assessments for licensing of study programmes and 69 assessments for accreditation of study fields (study programme groups).

The analysis looks at the national restrictions caused by the COVID-19 pandemic, related changes to AIKA assessment methodologies and provides statistics on the site visits conducted in this period.

Further, the analysis focuses on three specific topics – general provision of online visits, assessment of the resources and provision of higher education institutions in online mode and ensuring the quality of online visits from the perspective of all involved parties.

Overall, the feedback has been positive. However, a number of shortcomings and suggestions for improvement have been identified, especially from the perspective of review experts.

Unibasq was granted an ECA strategic project to agree on recommendations for external quality assurance of student centred-learning (SCL).

There is a lack of a common approach about the concept of SCL and for Quality Assurance Agencies, it is still a challenge how to address it. Therefore, the main objective of this proposal is to provide a common understanding of what SCL can be and to give recommendations on how to address it. The expected impact will be to find a common understanding based on the current practices and to see how to address SCL in the external QA procedures considering the different ways HEIs can approach SCL.

The benefits will be that it will be easier to address SCL and to promote good practices when detected by the external QA procedures, which will benefit HEIs and students, and will also help QA agencies when dealing with their own reviews against the ESG.
